## 1. INTRODUCTION AND BACKGROUND

### 1.1 Current Model of Distribution

The current model of distribution of 'Free Condoms' is based on the recommendations from an evaluation the C Card Model of distribution concluded in February 2010. The service began with 113 sites inherited from the previous 'C-Card' service. The Health Improvement Team – Sexual Health commenced management of the condom distribution in autumn 2010 and the service in its current format became fully operational as the 'Free Condoms' service in June 2011. This Annual Report outlines the work undertaken by NHS Greater Glasgow and Clyde (NHSGGC) Free Condoms service during the period January 2015 to December 2015. This 2015 annual report includes contributions from the Steve Retson Project (SRP) Health Improvement Team (Section 15), and the African Health Project at Waverley Care (Appendix 3).

Free Condoms is subject to review to ensure it is meeting its aims and objectives and adheres to the governance framework within which it is monitored. This includes ensuring that NHSGGC Free Condoms is underpinned by policy and NHS standards, which are outlined.

Improvements in 2015 include:

### 1.2 Policy and Guidelines for Free Condoms Work streams

The Sexual Health and Blood Borne Virus Framework<sup>1</sup> recommends that multi-agency partners should be working together to ensure services, including the provision of general sexual health advice, pregnancy testing and condoms, are available in areas of greatest need. Free Condoms prioritises defined need and inequalities, and condom venue provision is assessed against data on income deprivation, HIV prevalence and teenage conceptions to Intermediate Zone level.

<b>Sexual Health and Blood Borne Virus Framework Update (2015-2020)</b>	
<b>Outcome 1</b>	Fewer newly acquired blood borne virus and sexually transmitted infections; fewer unintended pregnancies.
<b>Outcome 2</b>	A reduction in the health inequalities gap in sexual health and blood borne viruses.
<b>Outcome 4</b>	Sexual relationships are free from coercion and harm.

The Standards for Sexual Health Services<sup>2</sup> apply to sexual health services, and state:

*'Provision of safer sex advice, condom distribution schemes and infection prevention is an integral function of specialist sexual health services.'* (p.4)

<b>Standards for Sexual Health Services (2008)</b>	
<b>Standard 1</b>	A comprehensive range of specialist sexual health services is provided locally and individuals with the greatest need are treated as a priority.
<b>Standard 3</b>	NHS Boards ensure the development and delivery of integrated approaches to sexual health improvement, particularly in relation to young people.
<b>Standard 5</b>	Individuals attending for ongoing HIV care are offered high quality sexual and reproductive healthcare to improve personal wellbeing and to minimise the risk of transmitting the infection to others.

The Free Condoms Service is also aligned with Standards for HIV Services<sup>3</sup> – Standard 1 and Standard 3.

<b>Standards for HIV Services (2011)</b>

### 1.3 Target Populations

The following populations are defined as target populations for the Free Condoms Service:

- People living with HIV.
- People most at risk of acquiring HIV infection, including men who have sex with men (MSM).
- Black African Population.
- Young adults aged up to 24.
- Sexually active young people aged 13 to 15.
- People living in SIMD<sup>4</sup> Quintile 1 & SIMD Quintile 2 areas, including Intermediate Zones with high teenage conception rates, HIV Prevalence, and Income Deprivation.

Free Condoms also aims to provide to people with added vulnerability such as disability, homelessness or asylum seekers. Agencies working with such vulnerable groups can offer the Free Condoms to their clients/service users.

### 1.4 Aims and Objectives

The aims and objectives of the Free Condoms Service were defined in November 2010 prior to the development and launch of the service. A full copy of the Aims and Objectives Paper can be found at Appendix 1. These will be reviewed in 2016. The seven primary aims of the service are:

- To identify appropriate target groups based on identified need.
- Monitor and review performance of delivery of the service in order to create and maintain effective partnerships which enable service development and delivery.
- To provide an available and accessible quality service.
- To establish and maintain effective communication with current and future service users.
- To provide a responsive service that addresses the needs of service users.
- To contribute towards the evidence base and inform future policy and services.
- To ensure appropriate accountability and governance.

## **2. SERVICE PROVISION**

### **2.1 Condom Supply**

The tender for the supply of condoms was processed in autumn 2010. The 18 month contract was awarded to Pasante Healthcare Ltd to run from December 2010 – May 2012. This was extended to March 2013 with the potential for the contract to be extended on a year by year basis for a further 4 years. The contract was further extended for 2014-2015, and is currently in process to extend for six months until 30<sup>th</sup> September 2016.

Condoms and lubricant are packaged by Pasante into discreet plain packaging clearly marked with a label coding the contents and use-by date. Pasante deliver directly to each distribution venue. There is a minimum order to avoid carriage costs.

### **2.2 Product Range**

The product range reflects the needs of target groups and is in line with current evidence regarding condom effectiveness. The list of products currently offered to distributors/service users is attached as Appendix 2. There are 12 condoms in each pack with the exception of the STN x 3, which contains 3 condoms. Lubricant packs contain 12 x 10ml sachets. This range is available to all our Free Condoms venues. Clinic boxes (144 condoms) and eco packs (288 condoms) can also be supplied to agencies such as addiction services.

### **2.3 Provision for Service Users**

The current condom distribution service, branded as 'Free Condoms' is designed to be a user friendly service for both the service user and for those involved in distributing condom products.

The main features of 'Free Condoms' for service users are:

- Condoms/lubricant is accessible throughout the health board area.
- Condoms/lubricant is accessible from a range of agencies.
- There is no requirement to register or provide personal details as a service user.
- 'Membership' cards are not required.
- There are no restrictions regarding the amount of times condoms/lubricant can be obtained.
- The service is discreet and simple.
- Condoms/lubricant is provided in discreet packaging.
- A range of condoms are available, including different sizes and latex free.

### **2.4 Free Condoms Venues**

The main features of Free Condoms Venues are:

- The transaction involved in providing a condom pack is simple and discreet.
- There is no requirement to record transactions or complete paperwork.
- Condoms are available from a range of agencies.
- Condoms/lubricant is ordered from the Free Condoms team and is delivered directly to the venue.
- Delivery occurs within 10 days of ordering and condoms/lubricant is delivered pre-packaged into packs of 12.

### **2.5 Service Development**

During 2016 a company will be commissioned to undertake a snapshot (e.g. age, gender) of the users of the service, and user experience. The results from this will provide information in order to ascertain if we are reaching the target populations, and plan service development accordingly.

### 3. TRAINING AND INFORMATION FOR VENUES

#### 3.1 Training and Information Sessions 2015

Training and information sessions are currently provided face to face to support recruitment and development of venues. These include 1:1 and presenting to staff teams. Information sessions are also offered to services who may wish to find out more about Free Condoms without necessarily becoming a venue e.g. they may wish to find out about policy and standards, and how they align to the provision of sexual health services and/or how to signpost to the service to support the work that they do. In line with quality service provision training materials are reviewed periodically to ensure they are aligned to best practice and service standards. Training and information materials are available on the Free Condoms website.

#### 3.2 Electronic Handbook

The Service Handbook (distributed as a hard copy handbook) was created prior to the service launch in 2011. An electronic version of the handbook is available at the Free Condoms Website under the professionals section, and the printed version will be discontinued. The electronic handbook includes information on a range of topics including service procedures and operation (including expected service standards), information on products, providing guidance on condom use and an in-depth section on providing condoms to young people under the age of 16.

## 4. FREE CONDOMS WEBSITE

### 4.1 Free Condoms Website – Service Users

Information for current and potential service users is delivered via Free Condoms website [www.freecondomsglasgowandclyde.org](http://www.freecondomsglasgowandclyde.org)

A new Free Condoms website was created during 2015. This sits alongside new and updated Sandyford Sexual Health Services websites. A digital media project manager oversaw this process, and a 'soft launch' of the Free Condoms website was undertaken at a Sandyford Services training event at the Campanile Hotel on 9<sup>th</sup> February. The improved website retains the 'branding colours' of Free Condoms. Highlights include:

- Choice Card for phone or tablet – can be selected from the website and used exactly like a choice card to indicate product choices.
- Feedback Button. Service users can provide feedback and comments on their experience of the service. This will subject to content review on a scheduled basis.
- Links to Sandyford Website including Sandyford Twitter - including promotions of the Free Condoms service.
- Links to Steve Retson Project (for men who have sex with men).

- Quick exit button from the website
- YouTube short film '*how to put a condom on*'<sup>5</sup>

There are also plans to update the current information leaflet contained in condom packs to include the website address, inviting service users to provide feedback via the website.

### 4.2 Free Condoms Website – Professionals Section

A section of the 'Free Condoms' website is designed for use by professionals involved in condom distribution. It provides information to current service providers as well as providing information for potential new venues (who have the option of 'signing up' to the service by providing their details via an on-line form). Other topics in the professionals section include information on products, and information/training materials.

### 4.3 Free Condoms Website – Analytics

In 2015 a total of 25,950 visits were made to the Free Condoms website<sup>6</sup>. This is an increase from 2014 (17,771 visits). During 2015 an increase is seen from June, although this began to drop in August. Reasons for the increase may include the publication of the new Sandyford Sexual Health Service and Steve Retson Project websites, both with links to the Free Condoms website.

Development plans will include consideration of marketing the service to driver users to the website. This will include targeted marketing campaigns based on emerging evidence during 2016. 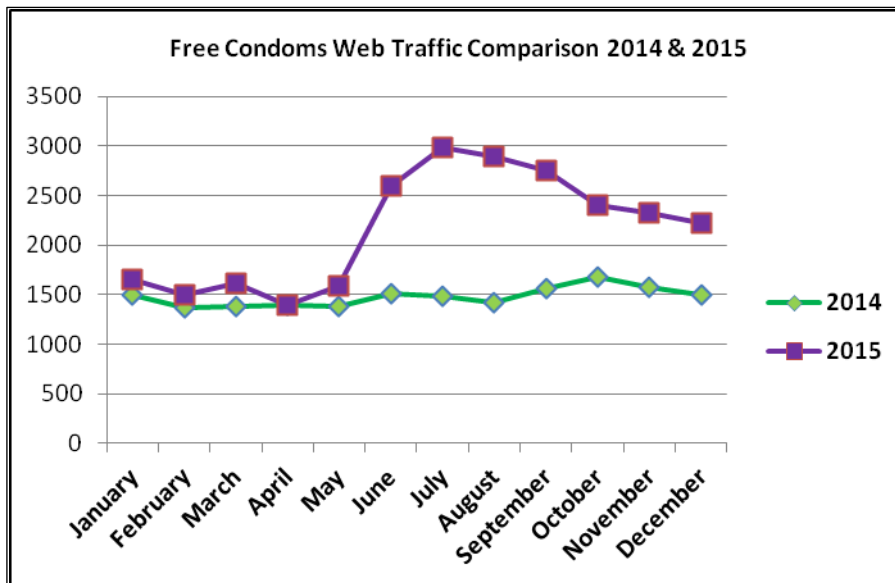

Chart 1 - Free Condoms Website Comparison



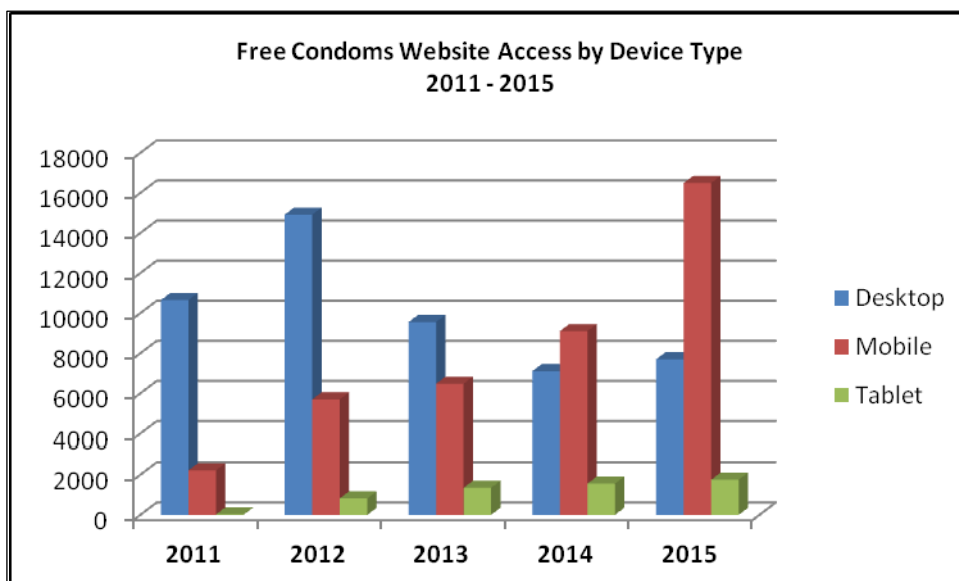
#### 4.4 Devices used to access Free Condoms Website

Devices used to access the Free Condoms website show that desktop access has declined significantly from 82.6% in 2011 to 29.7% in 2015. This correlates with an increase in mobile devices (63.6% for mobiles & 6.8% for tablets in 2015). These statistics supported the development of a choice card for mobile and tablet platforms available from the website.

## 5. MARKETING

### 5.1 Free Condoms - Marketing Resources

The service supports Free Condoms venues by providing the products listed below. In 2015 we added pens with the website address printed on them. These are available in the three branded colours of orange, purple and green.

### 5.2 Free Condoms - Campaigns 2015

Free Condoms commissioned CJC Media to undertake a marketing campaign to place panel posters into male and female washrooms in licensed premises, community centres and other venues. This was a targeted campaign to increase the profile of the service and signpost to the Free Condoms Website. Panel posters were placed in 113 venues, which were chosen to target SIMD 1, SIMD 2 and areas of high teenage pregnancy. These were selected in Glasgow City and Renfrewshire for this campaign, which ran from 7<sup>th</sup> December 2015 – January 8<sup>th</sup> 2016.

During 2015 Free Condoms advertisements were also placed in the following student publications:

- The Student Advertiser – 2 publications
- The Student Rag – 1 publication

### 5.3 Marketing in Further and Higher Education

Condom venues are also available within colleges and universities. There are 25 venues on campus throughout NHSGGC where Free Condoms can be accessed, which is an increase from 19 in 2014. We support Fresher's events at the beginning of academic years with promotional materials and extra condom supplies. This includes training of any new students who volunteer to be involved in the distribution from their campus. Fresher's events also provide an opportunity to promote and sign-post the service.

## 6. NATIONAL CONDOM DISTRIBUTION SERVICES NETWORK

The Scottish national network for those involved in condom distribution services was refreshed in 2015. It is a chaired group with terms of reference that will meet bi annually. The group met in February and September 2015.

The remit of the group includes:

- Sharing best practice, evaluation and learning from individual schemes.
- Highlight areas of concern and agree a co-ordinated response where appropriate.

It has been agreed that the group would be known as the '**National Condom Distribution Services Network**'. There is also an online community space in the knowledge network <http://www.knowledge.scot.nhs.uk/home.aspx>.

NHS Greater Glasgow and Clyde Free Condoms will host the next meeting in Glasgow in March 2016.

## **7. EQUALITY IMPACT ASSESSMENT (EQIA)**

An Equality Impact Assessment (EQIA) Assessment for Free Condoms was signed off in 2015. Conducting EQIAs is a legal duty for the Board and promotes the provision of services that are 'sensitive to inequalities'. EQIA's are internally quality assured. EQIA's are published by NHSGGC on their website.

The Free Condoms EQIA identified particular actions to take forward including assessing for the provision of a general service leaflet that may be translated into other languages.

The Free Condoms Service EQIA requires ongoing six monthly reviews, which will provide detail on actions/activity identified from the original EQIA. One of these has already been completed with the provision of a feedback button for service users in the new Free Condoms website.

## 8. DEFINITIONS APPLIED TO ACCESSING FREE CONDOMS VENUES

Inconsistencies in applying definitions of access to venues by service users were identified from the mapping exercise undertaken in 2014-2015 (to identify gaps in the provision of Free Condoms). Previously there were two definitions applied, which were 'open access' and 'limited access'. Inconsistencies included colleges/universities and in some cases GP surgeries were defined as 'open access'. This implied universal access to all populations when in reality you would not be able to access condoms from a GP surgery unless you were a registered patient or were unlikely to go to student services unless you were a student at a college/university. An improved model of defining client access was proposed and signed off during 2015, and the Free Condoms database updated to reflect those changes. This will support regular performance monitoring of provision, including identifying gaps in provision. The model of definitions applied to access is set out below.

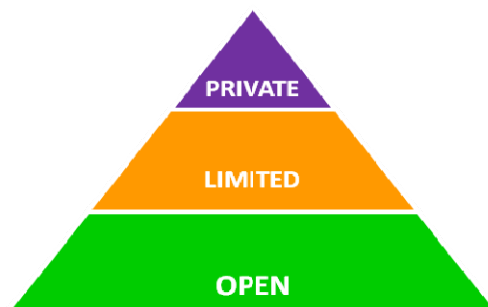

### Definition: OPEN

All populations of NHSGG can access venues.

### Definition: LIMITED

Access is limited to a specific population e.g. patient at a GP surgery, student at college/ university, and for service users of organisations (not open to the general public).

### Definition: PRIVATE

Access is via specific services.

For example:

- People in prison
- Looked After & Accommodated young people
- Men and women involved in prostitution

## **9. VENUES – ASSESSING PROVISION**

### **9.1 Active & Inactive Venues**

During 2015 Free Condoms reviewed the number of 'active venues' as there were a number of venues that were not ordering. There are a variety of reasons for 'low ordering'. These can include:

- The service has ceased to operate
- Change of ownership/new staff
- There is no demand
- There are venues that provide to small numbers of service users. In these cases the venues are retained.

Venues were contacted from April in a structured process that included letter and email and telephone. When the process was complete the distribution database was updated, and a number of venues made 'inactive'. Any venues made inactive can be made active again at any time. The service seeks to ensure that it attributes the reports on the number of condoms and lubricant to active venues. During 2015 a total of 60 venues were made inactive.

### **9.2 Free Condoms Mapping Update**

During 2014 a mapping exercise of NHSGGC condom venue provision was undertaken to assess current service provision and future service delivery is based on evidence including data on the Scottish Index of Multiple Deprivation (SIMD) including Income Deprivation, with Teenage Conceptions Rates, and HIV Prevalence. An outcome from this exercise is that we now record every condom venue to Intermediate Zone level. Consequently this means we can now assess provision of venues to Intermediate Zone level on request and on regular reporting mechanisms. During 2015 there was some recruitment of venues to gaps, but this remains ongoing in localities. It is also intended to have a recruitment 'drive' during 2016.

### **9.3 Venues Provision**

Free Condoms venues data are provided for:

- i. Venues excluding Sandyford Hubs and Satellites
- ii. Sandyford Hubs & Satellites
- iii. Partner agencies
- iv. All venues combined

The purpose of setting out statistics for venues including and excluding Sandyford services is to add value to information and interpretation of the figures and assessment of provision of venues out with and within specialist sexual health services. Please note that in assessment of venues to Intermediate Zone level all Sandyford hubs and satellites venues are classified as OPEN access.

### **9.4 Partner Agencies**

These are the African Health Project (AHP) and Brownlee Centre. These are coded on the Free Condoms database separately.

### **9.5 Bars/Clubs & Saunas**

In the 2014 annual report we reported on 'LGBT Commercial Venues' which are bars/clubs and saunas. These venues are provided with free condoms and lubricant targeted to men who have sex with men (MSM), and are now included with other bars and clubs Free Condoms provide to. Saunas are identified by a different business type. Information on provision on any of these venues can be extrapolated at any time and a breakdown of Commercial MSM venues if provided in Section 15.

## 10. RECRUITMENT OF VENUES 2015

There were 30 venues recruited during 2015. These included 4 Glasgow Kelvin College campuses and 12 pharmacies.

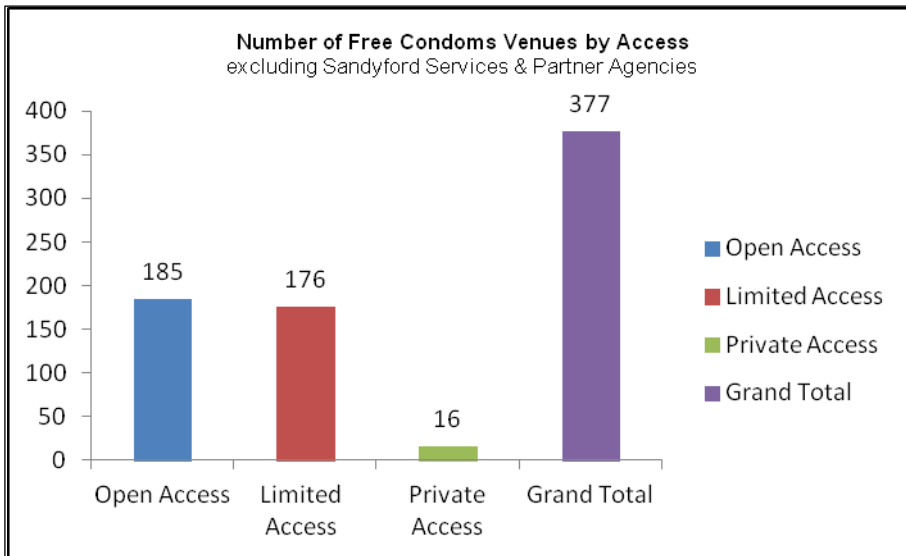

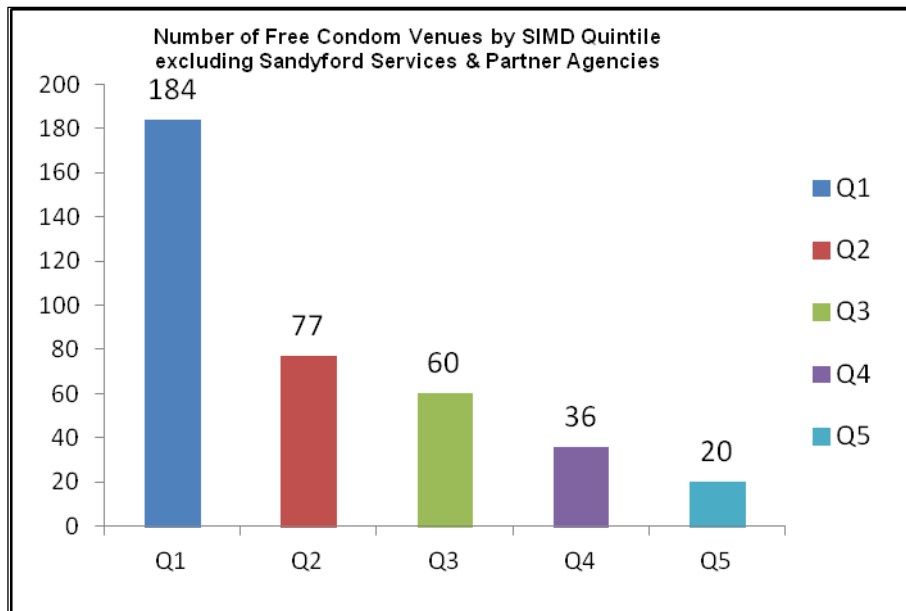
Chart 3 - Access Split - Free Condom Venues excluding Sandyford Services & Partner Agencies

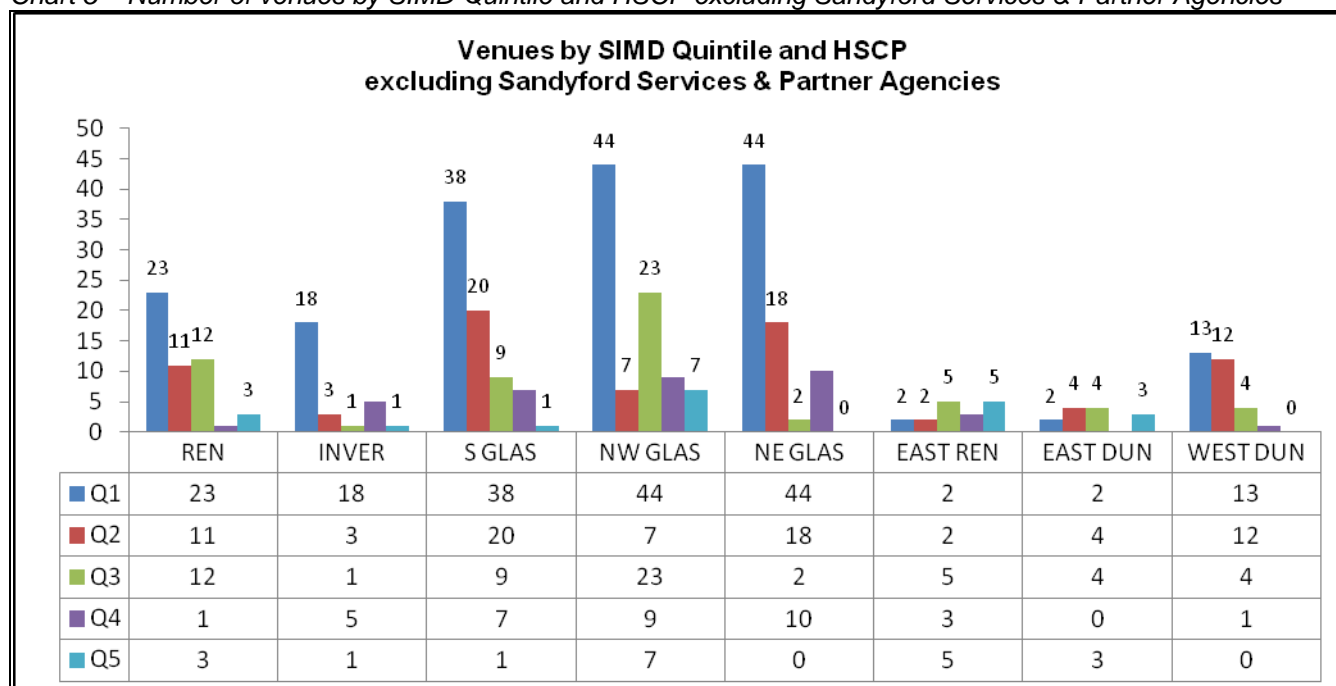
Chart 4 – Number of Free Condom Venues by SIMD Quintile excluding Sandyford Services Partner Agencies.

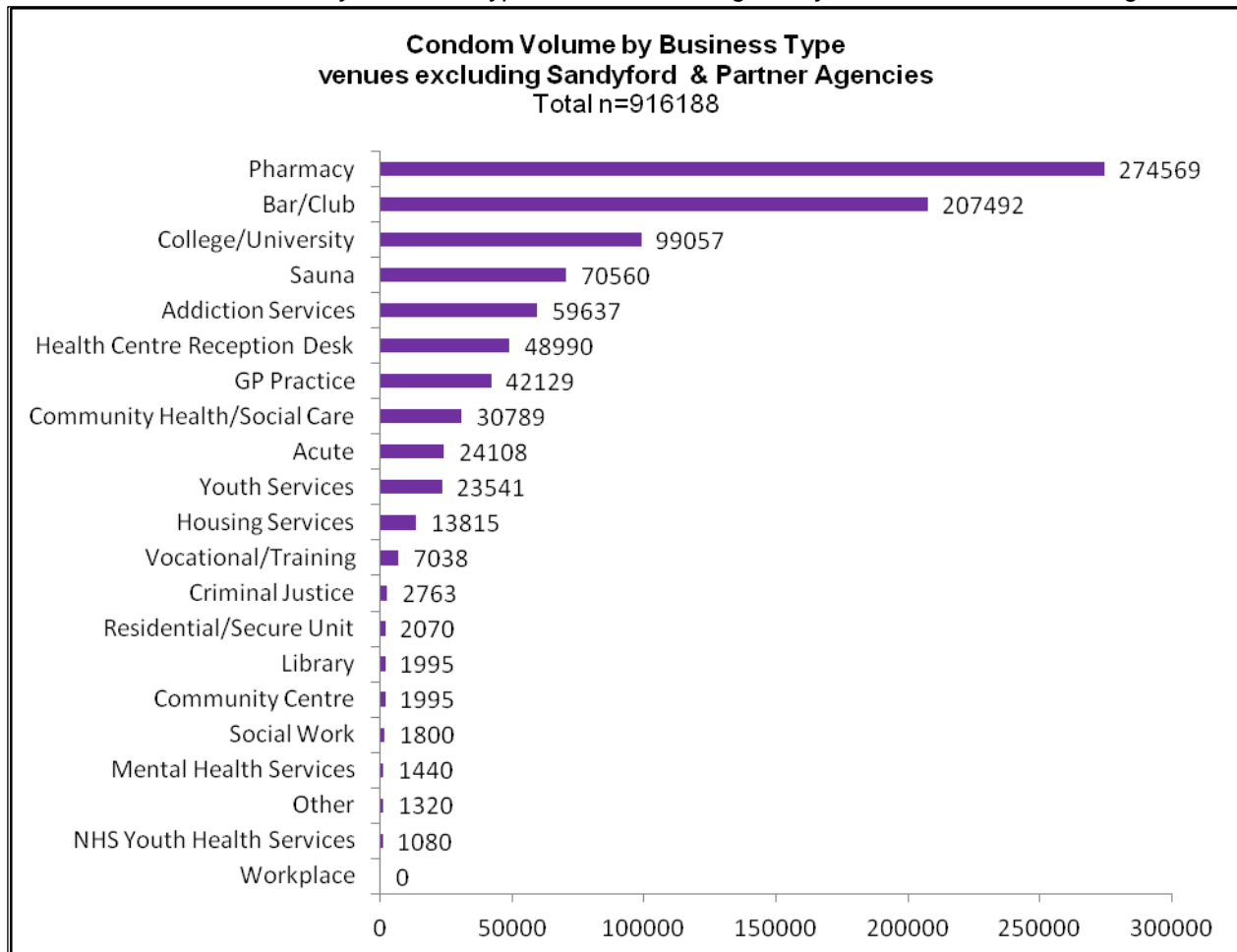

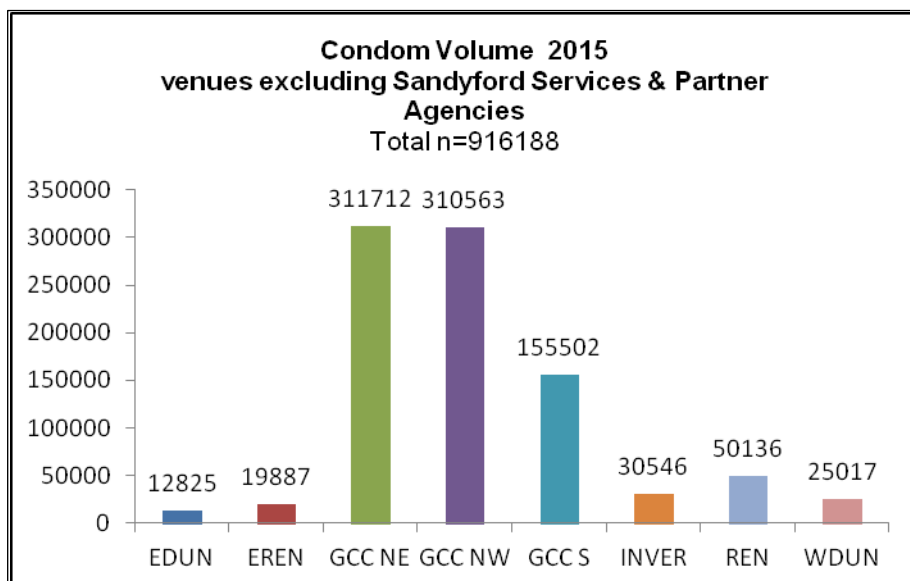
Chart 6 – Condom Volume by Business Type Venues excluding Sandyford Services & Partner Agencies

Chart 8 - Lubricant Volumes by Business Type excluding Sandyford and Partner Agencies

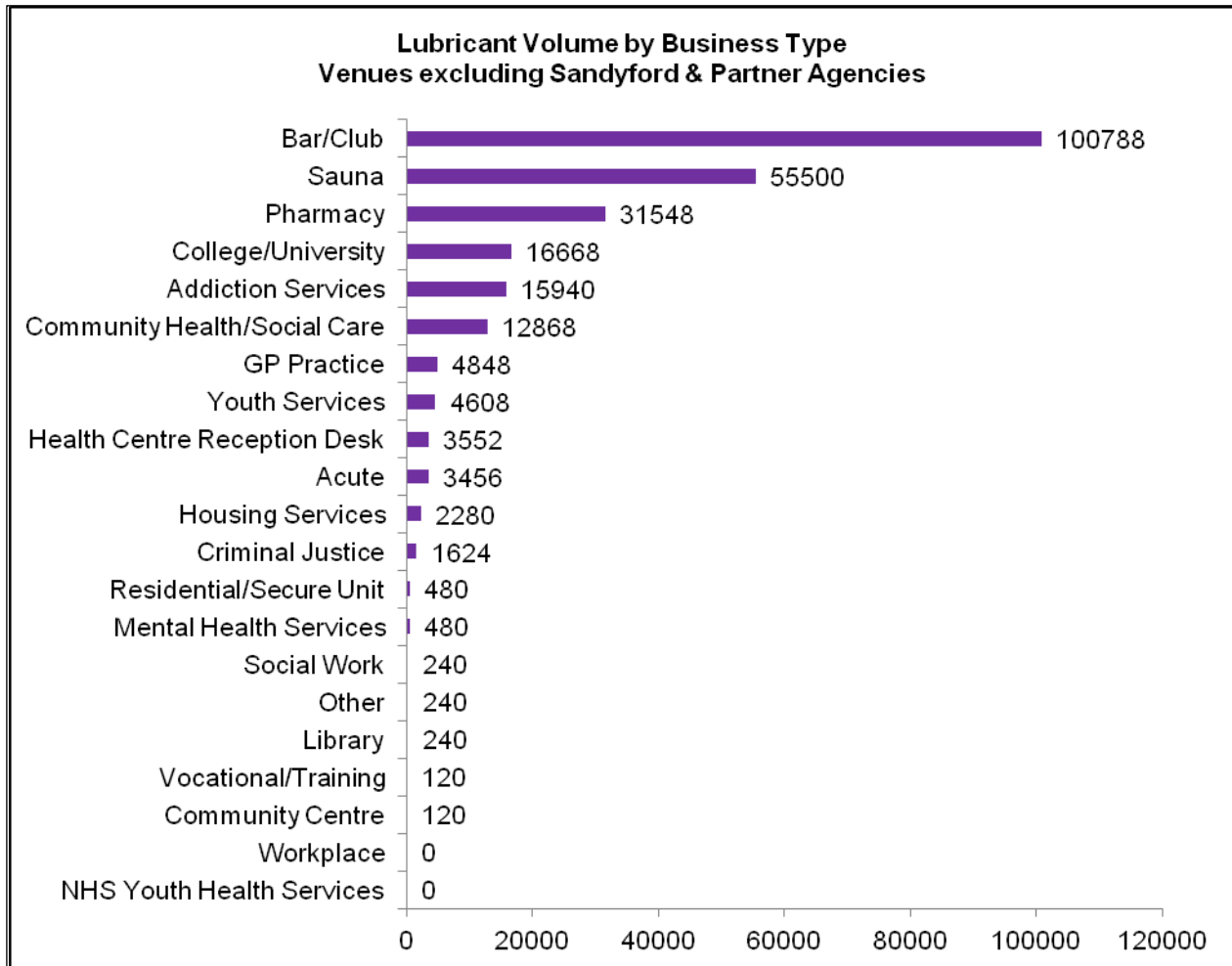
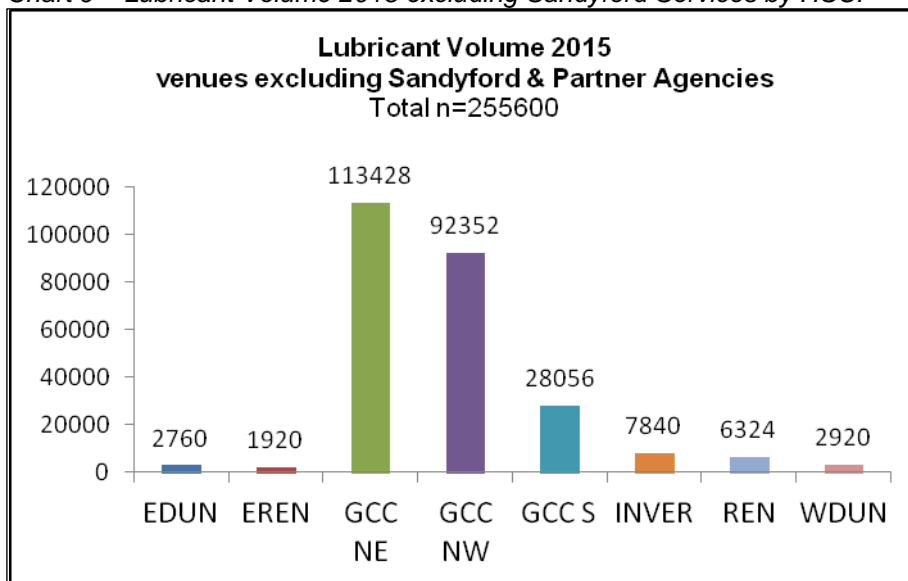


Chart 9 – Lubricant Volume 2015 excluding Sandyford Services by HSCP

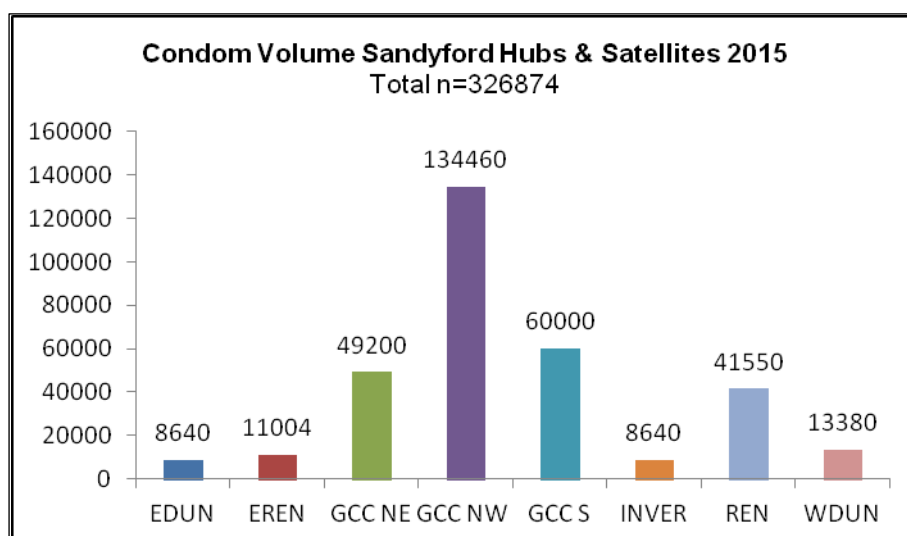

Chart 10 - Condoms ordered by Sandyford Hubs & Satellites by HSCP



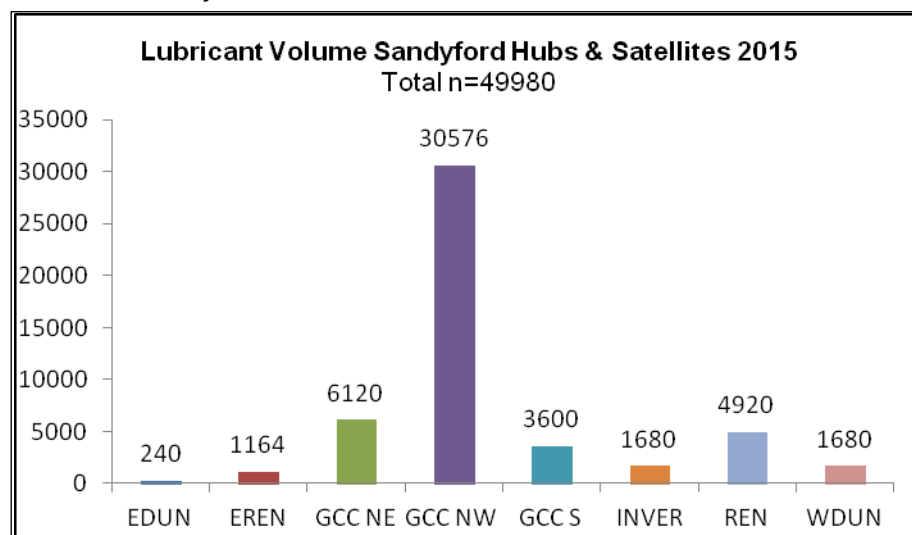

Chart 11 – Sandyford Hubs & Satellites Lubricant ordered 2015

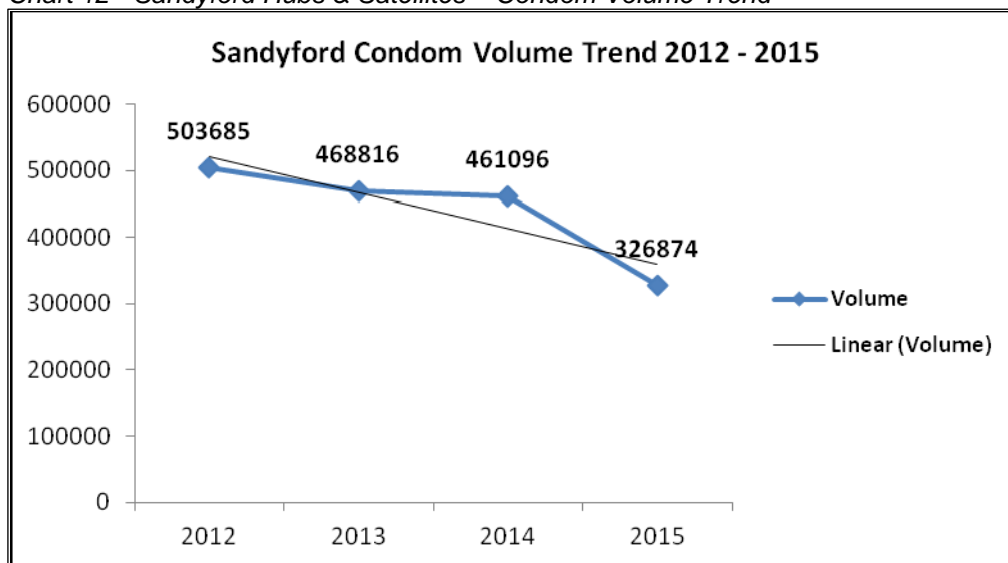

There has been a reduction in the volumes of condoms ordered and supplied to Sandyford Hubs and Satellites. This difference between 2014 and 2015 is **94,419** condoms. Numbers of condoms reported on in previous years for Sandyford will have included condoms ordered for the Free Condoms Service (for marketing, training and other information sessions). Consequently any figures quoted in prior years for Sandyford will show variance from the figures here.

To ensure a robust comparison a retrospective report was run for years 2012 – 2014 for Sandyford Services Hubs and Satellites to ensure that condom volumes could be compared accurately between years, and particularly for the difference from 2014 – 2015. This report was run using the same parameters and search for the years 2012 – 2015 and is therefore comparable.

Possible impacts for the reduction may include:

- i. Stock ordered for 2014 may have impacted on order requests for 2015.
- ii. Following service change from Gay Men’s Health to Steve Retson Project in October 2014 leftover stock was being utilised.
- iii. People are accessing condoms in other venues out with specialist services.

There may be other possible reasons for the reduction in ordering, which will be more fully considered with colleagues and partners.

### 13. AFRICAN HEALTH PROJECT

#### 13.1 Provision of Products

Free Condoms provides products to the African Health Project at Waverley Care to support the team to deliver provision to the African population in NHSGGC. Staff from the African Health Project has directly provided some contextual narrative on the work that is undertaken in the context of Free Condoms. This is provided in Appendix 3.

#### 13.2 Orders 2012-2015

The volume orders show a reduction from 2012, with a spike in 2014.

Chart 13 - African Health Project Condoms 2012 – 2015

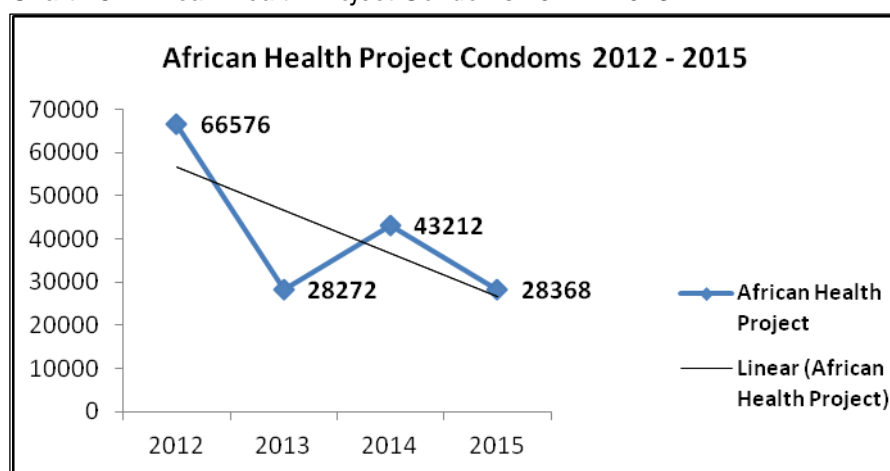

## 14. BROWNLEE CENTRE

### 14.1 Provision of Products

Brownlee provide Free Condoms to its patients and service users. This includes people diagnosed with and living with HIV. Service users attending the Travel Clinic at the Brownlee may also access Free Condoms via the Reception Area. It appears there is a reduction in the volume of condoms ordered from 2012 – 2015, with a spike during 2014. Reasons for this may include:

- Higher levels of stock ordered in 2014 not used impacted on the numbers ordered during 2015.
- People diagnosed and living with HIV being stable on treatment and require fewer attendances at Brownlee.
- People who attend Brownlee may access Free Condoms service elsewhere in venues that are more convenient to them in addition to attending Brownlee on an infrequent basis

Chart 14 - Brownlee Condoms 2012 – 2015

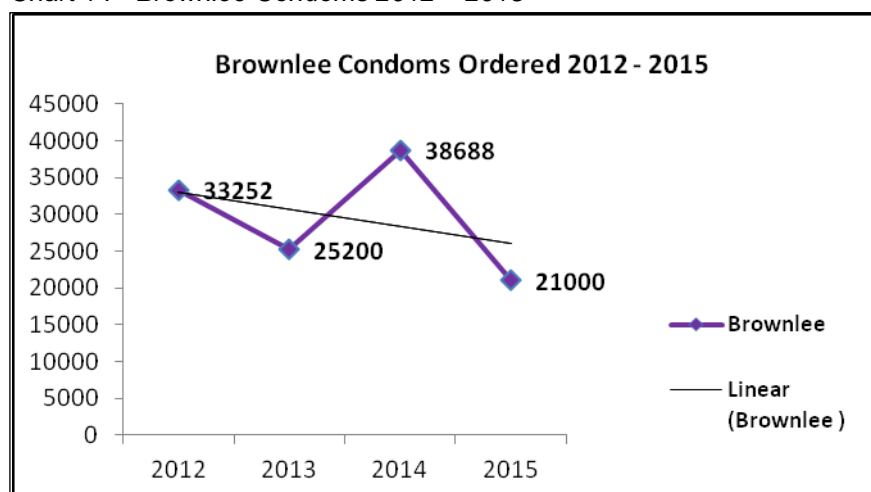

## 15. STEVE RETSON PROJECT

### 15.1 Provision

The targeted provision of free condoms and lubricant to men who have sex with men (MSM) in Greater Glasgow & Clyde is coordinated by Steve Retson Project (SRP) as a dedicated project within the wider Free Condom Service.

The SRP free condom project shares the same policy and guideline drivers (Section 1:1.2) and overarching aims and objectives (Section 1: 1.4) as the wider service, while also working towards "Outcomes for Men" 4 & 5 as defined in the Steve Retson Project Health Improvement Development Plan.

4. Men have the knowledge and resources to have enjoyable and pleasurable sex safely.
5. Men are able to access sexual health and HIV services which are appropriate to their needs

The provision of condoms and lubricant to MSM via the SRP free condoms project can be considered to have 3 distinct streams for the purposes of stock ordering and data reporting. These are:

- Via SRP clinics in waiting areas and consultation rooms.
- Via the SRP Health Improvement Team (e.g. at community events like *Pride Glasgow*).
- Via direct delivery to commercial MSM venues (bars, clubs & saunas).

### 15.2 SRP Free Condom Stream 1

The Steve Retson Project clinical team ensure the availability of condoms and lubricant at Sandyford Central and community based clinics. The total number of condoms ordered in 2015 was 2880 (Table 18). These were ordered as 240 ready made packets of 12 condoms designed to be given to as one item to men. A total of 1440 sachets of lubricant were ordered in 2015. There is not at this time data to compare previous year's lubricant totals with 2015.

Since May 2015 the SRP clinical and health improvement teams have shared a base. This may partly explain the reduction in total condoms ordered by the clinical team in 2015 as SRP have been better able to manage stock sharing one base.

### 15.3 SRP Free Condom Streams 2 & 3

For 2015 combining the volume of condoms and lubricant ordered by MSM commercial venues with that ordered by SRP Health Improvement will provide the closest like for like comparison with previous yearly totals reported by Gay Men's Health.

The distribution of free condoms to men through the commercial "gay scene" (stream 3) can be considered a structural level health improvement intervention. As such part of NHSGGC's commitment to provide a comprehensive and integrated tiered approach to primary prevention. Our intention being to reflect local needs by actively targeting one of the populations with the highest prevalence of HIV in greater Glasgow & Clyde.

At the start of 2015 the ordering and delivery process for commercial MSM venues employed by SRP changed from the model utilised in previous years. The new model links the owners and managers of commercial MSM venues directly with the SRP Health Improvement team. Orders placed with SRP are then delivered directly to venues by Pasante Healthcare Ltd.

In early 2015 the product range available was streamlined to provide a consistent offering across all MSM bars and clubs (Table 19), this change does not affect the saunas. SRP Health Improvement is able to order the full range of products available through the wider Free Condoms Service.

#### 15.4 Condoms

During 2015 streams 2 & 3 ordered a combined total of 271,872 individual condoms of which 244512 condoms were ordered directly by MSM commercial venues excluding SRP Health Improvement (Table 20).

The condom (Table 20) and lubricant (Table 21) order placed by SRP Health Improvement during Q1 of 2015 was intended to provide sufficient stock for the planned change to the new SRP Hub. No further orders were required by SRP HI during 2015 as a large volume of stock was inherited upon moving base with a further large volume of stock donated after Pride Glasgow 2015. It is unknown whether 2016 will require SRP HI to order more stock than 2015 to account for this. Conversely the direct to venue order model rolled out in 2015 might reduce the need for SRP HI to carry such a large back up stock freeing SRP HI to focus on ordering for specific planned health improvement events.

Informal feedback during 2015 from MSM commercial venues has been mainly positive. No venues expressed any concern at the reduction in products available to order. The direct to venue order model has enabled one company that owns 4 MSM venues in Glasgow to set up a standard repeat 2 weekly order which better suits their needs. Feedback regarding the new ordering model is that it's simple and allows the venues to manage their stock better themselves as they would any other aspect of their business.

## 15.5 Lubricant

During 2015 streams 2 & 3 ordered a combined total of 170 000 individual packets of lubricant of which 150 000 were ordered directly by MSM commercial venues (Table 21).

Excluding SRP HI quarter 1 saw the largest volume of lubricant ordered during 2015. One possible explanation may be venues restocking after the Christmas and New Year party season. It is also likely the conclusion of the Gay Men's Health contract in late 2014 left some venues under stocked at the start of 2015. The reduction in orders during quarter 3 can be partly explained by a temporary reduction in the number of MSM venues during that period.

Chart 15 - Total Volume of Condoms & Lubricant ordered by year

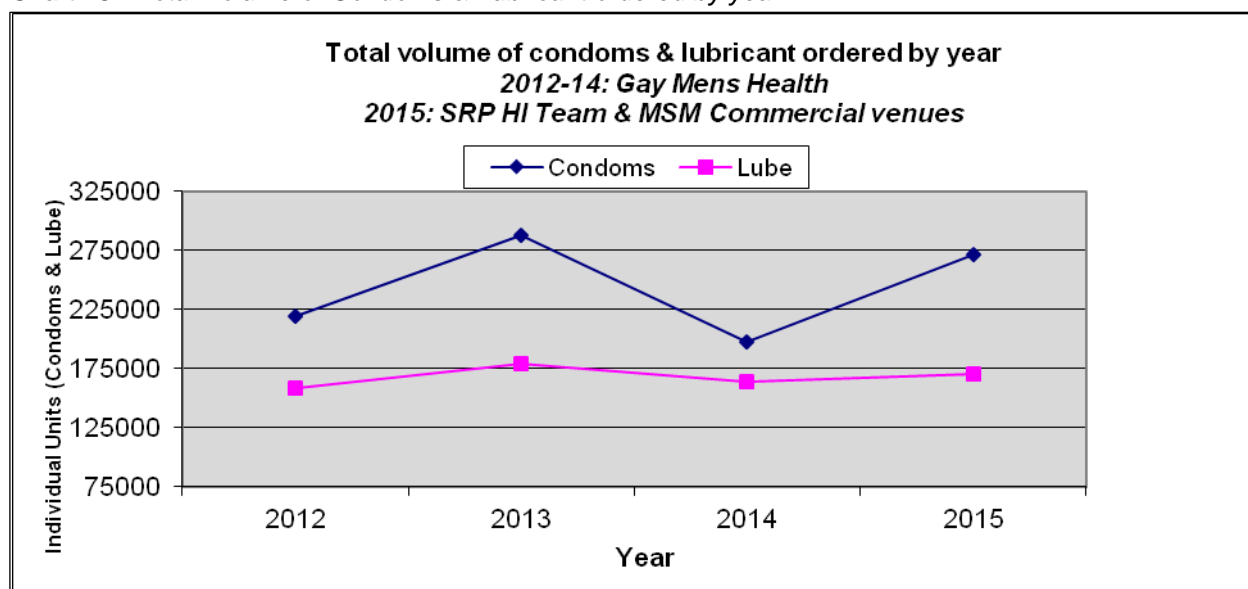


Chart 15 allows for comparison of the total units ordered between the years 2012-14 and 2015 the first full year of the new SPR free condom project. After a fall in total condoms ordered in 2014 partly explained by the cessation of the Gay Men's Health contract the volume of condoms has risen by over 70 000 during 2015.

A similar but less pronounced relationship exists when looking at the volume of lubricant ordered over the past 3 years. It is likely the slight fall in total lubricant during 2014 can partly be explained by the cessation of the GMH contract.

It is interesting to note that the reduction in condom and lubricant product types available to order by the MSM commercial venues has not so far appeared to cause any significant reduction in total units ordered. Suggesting a streamlined product range and change of ordering model has had no effect on the provision of condoms and lubricant to MSM while resulting in a lower total spend.

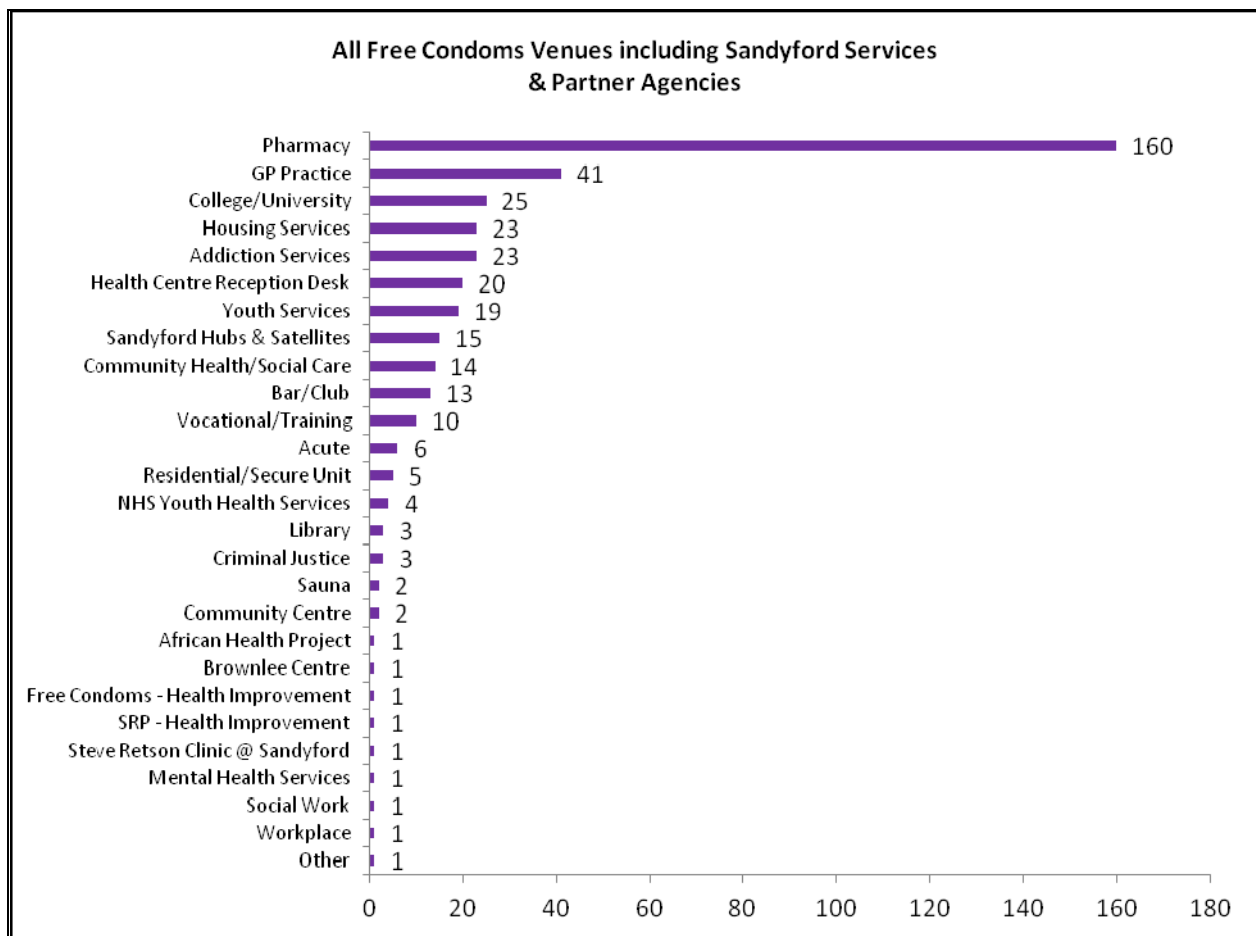

Chart 16 - Number of Free Condoms venues including Sandyford Services & Partner Agencies

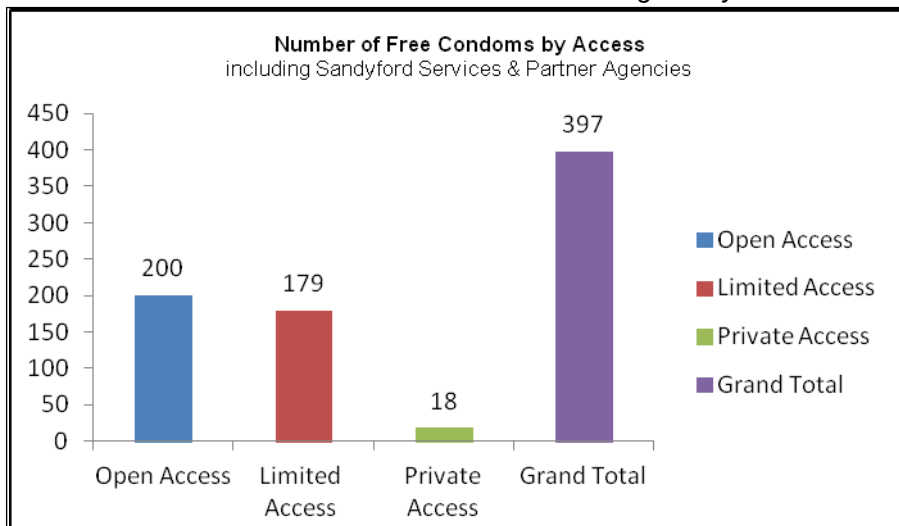

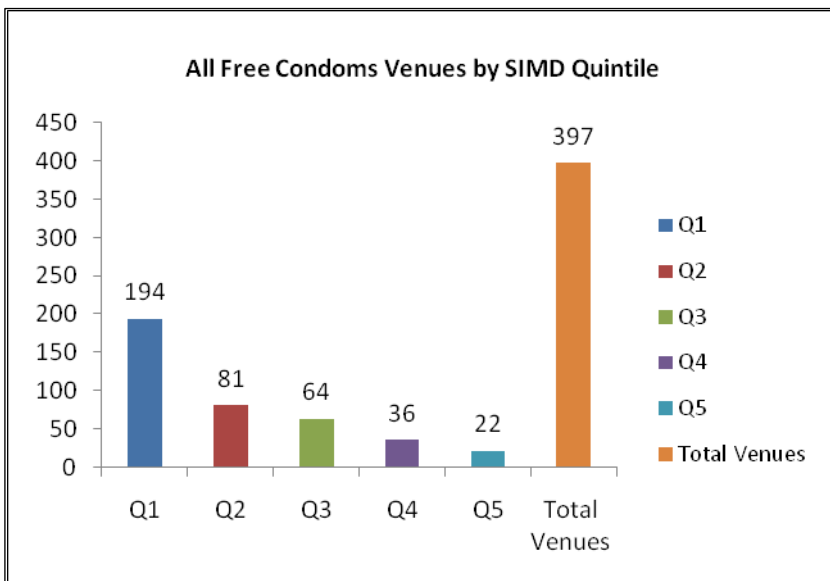
Chart 17 - Number of Free Condoms Venues including Sandyford Services & Partner Agencies

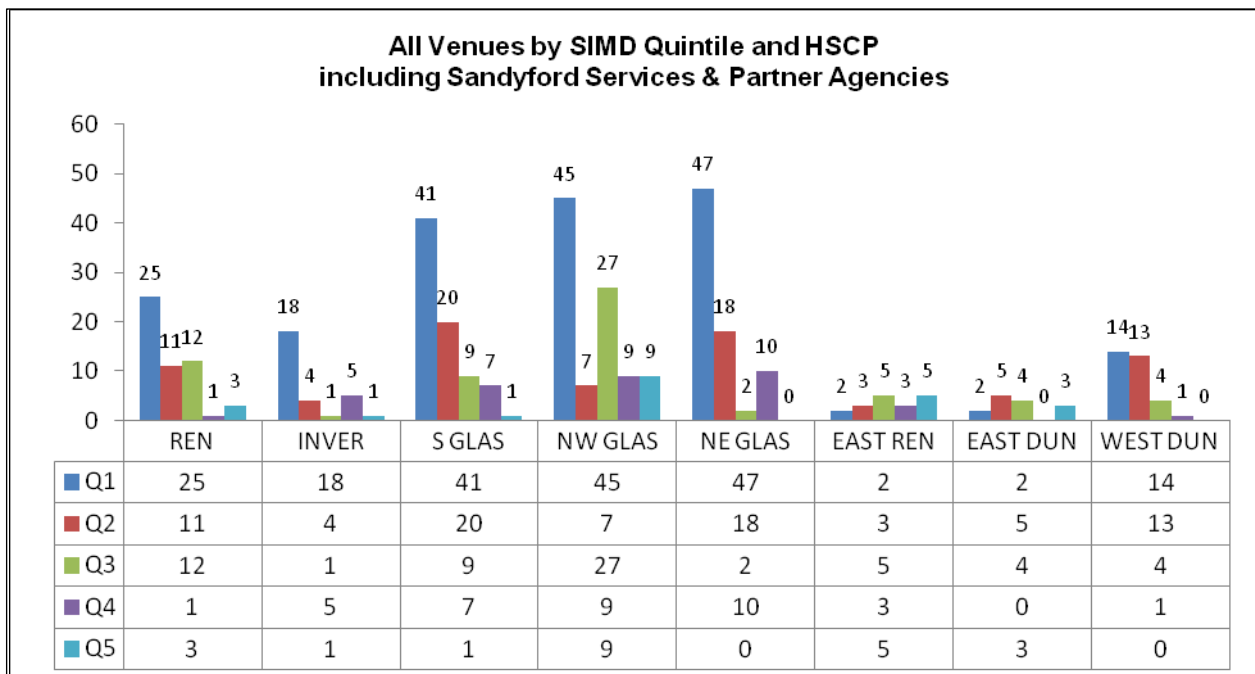

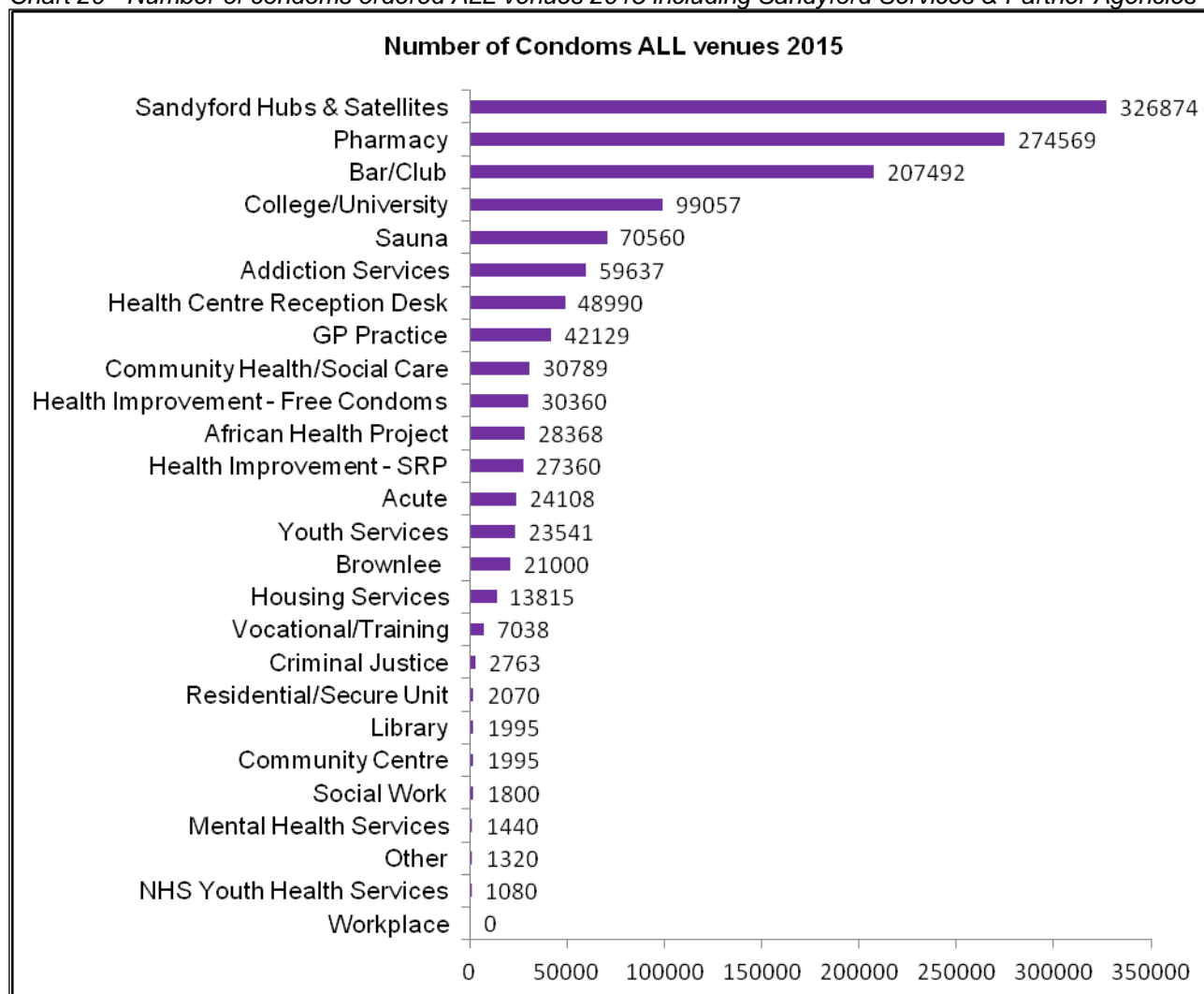
Chart 19 - All Venues by SIMD Quintile and HSCP including Sandyford Services & Partner Agencies

- Chart 23 shows the % volume of condoms by all business types including Sandyford Hubs & Satellites, and partner agencies.



- Sandyford Hubs & Satellites ordered **326,874** condoms. This is **24%** of total number of condoms ordered. Sandyford Hubs & Satellites therefore order the highest volume of condoms ordered.
- Pharmacies ordered **273,569** condoms. This is **20%** of total number of condoms ordered.
- Bars/Clubs ordered **207,492 condoms**. This is **15%** of total number of condoms ordered. Please note bars and clubs include provision to MSM commercial venues. See breakdown statistics extrapolated for MSM commercial venues that for Steve Retson Project – section 15.
- Sandyford Hubs & Satellites ordered more condoms than lubricant (**condoms 24%: lubricant 14%**)

Pharmacies are the most accessible venue to obtain condoms. There are 160 pharmacies that provide 20% of condoms (see Table 26). This appears disproportionately low. We will work with our colleagues in pharmacy provision to increase orders, particularly in target areas e.g. Intermediate Zones with high teenage conception rates and HIV prevalence.

Chart 21 – Total Volume Condoms 2015

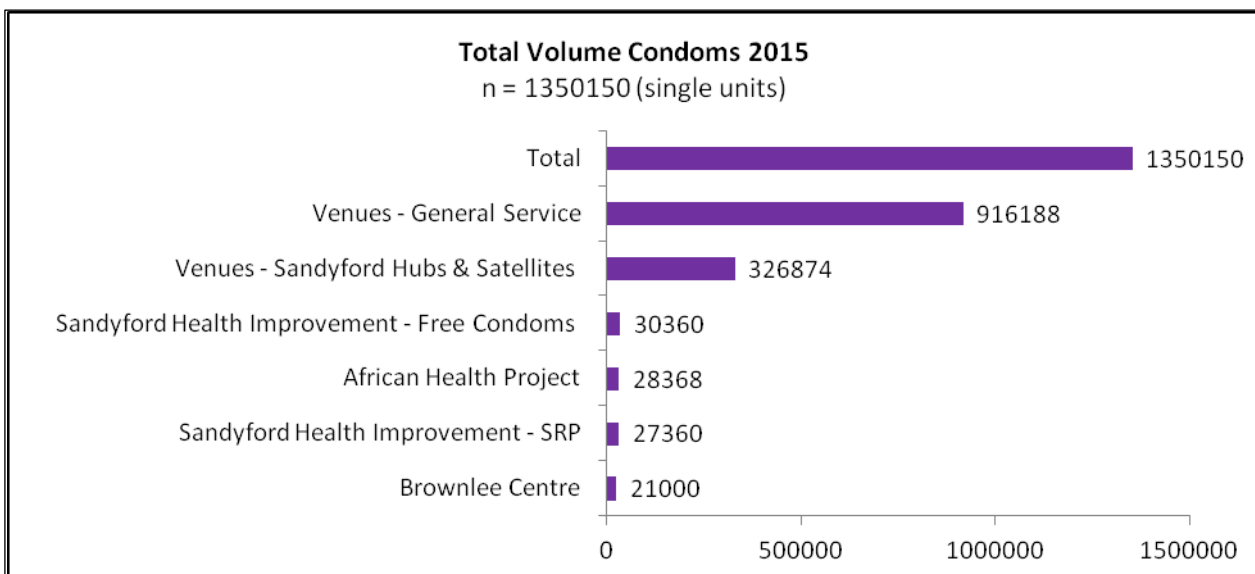


Chart 22 - Breakdown in Provision of Free Condoms 2015

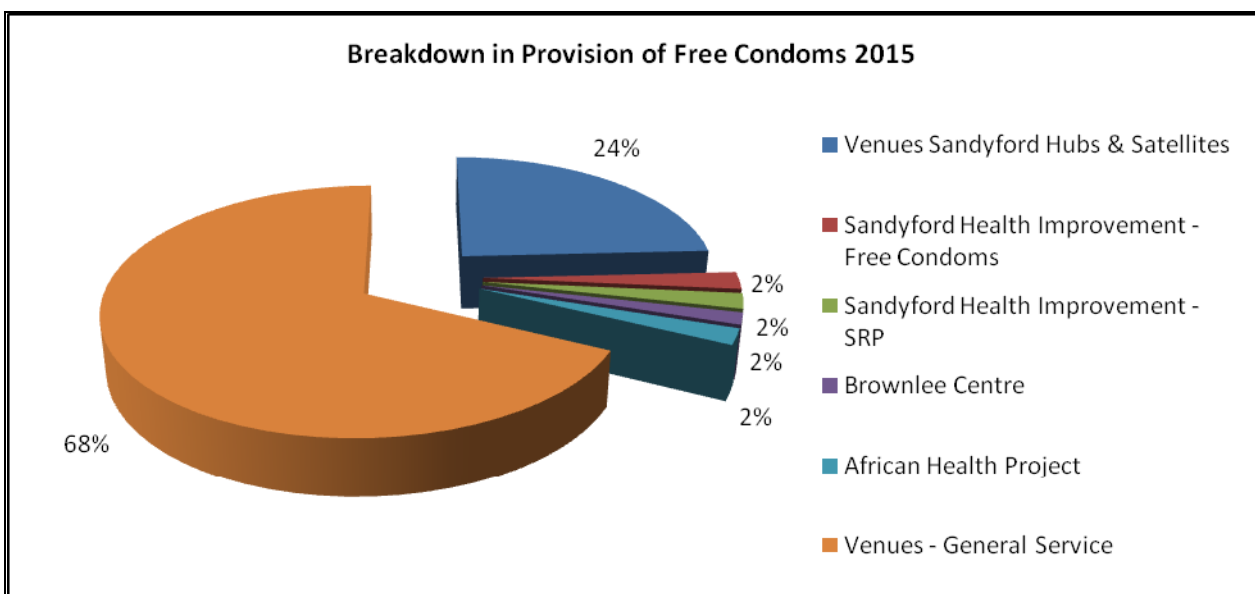
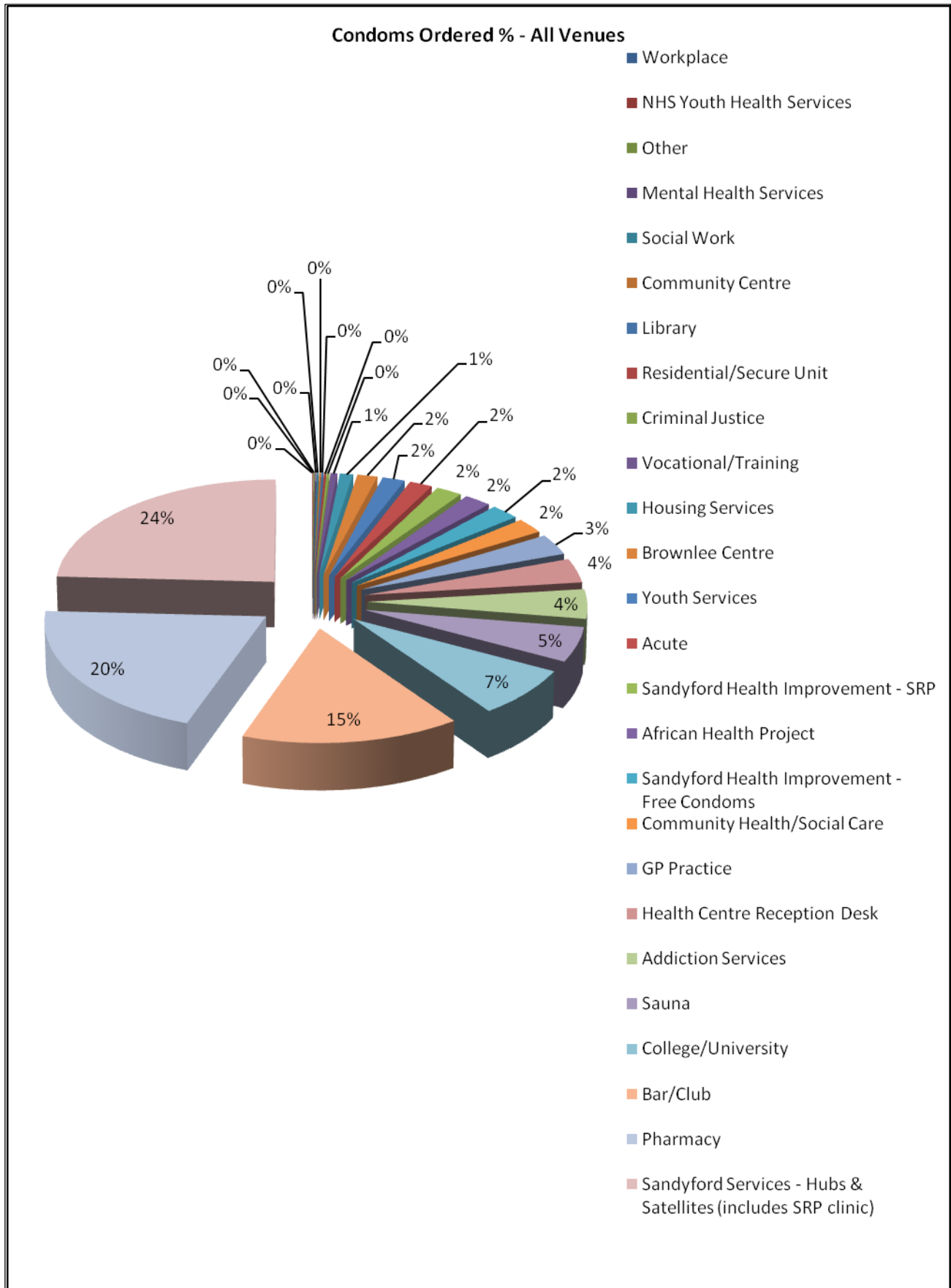


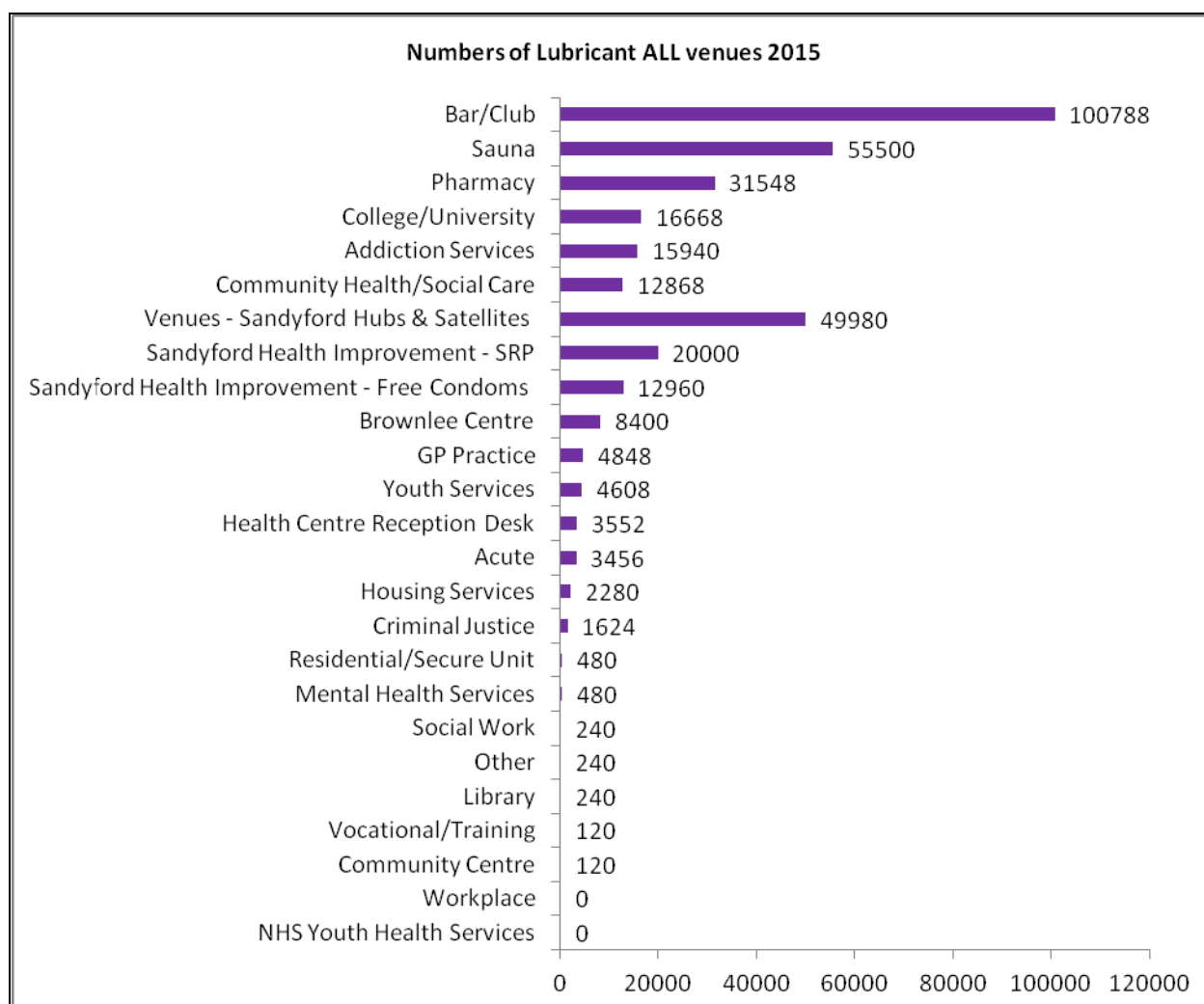
Chart 23 - % Breakdown of Total Number of Condoms Ordered 2015

Chart 25 - Total Volume Lubricant 2015

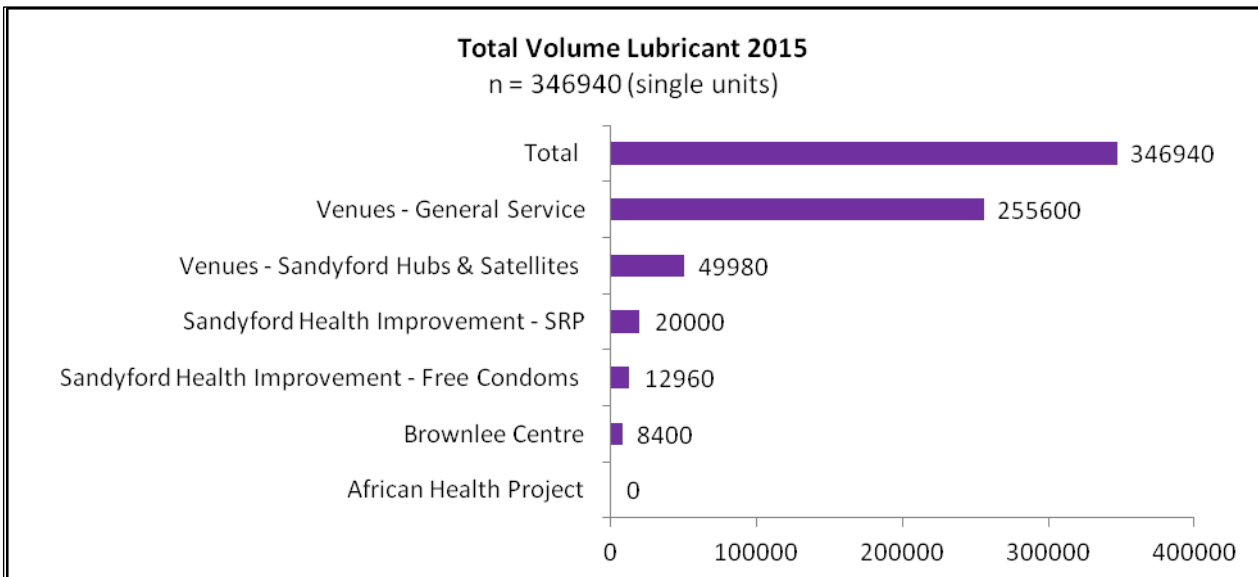


Chart 26 - Breakdown in Provision of Lubricant 2015

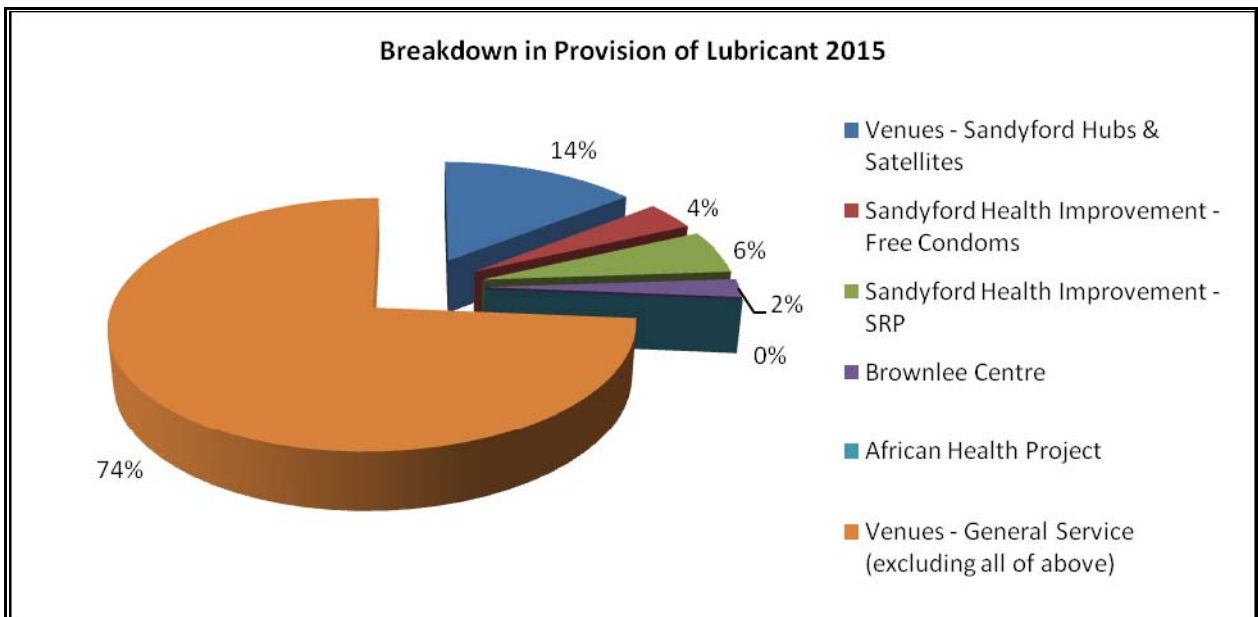
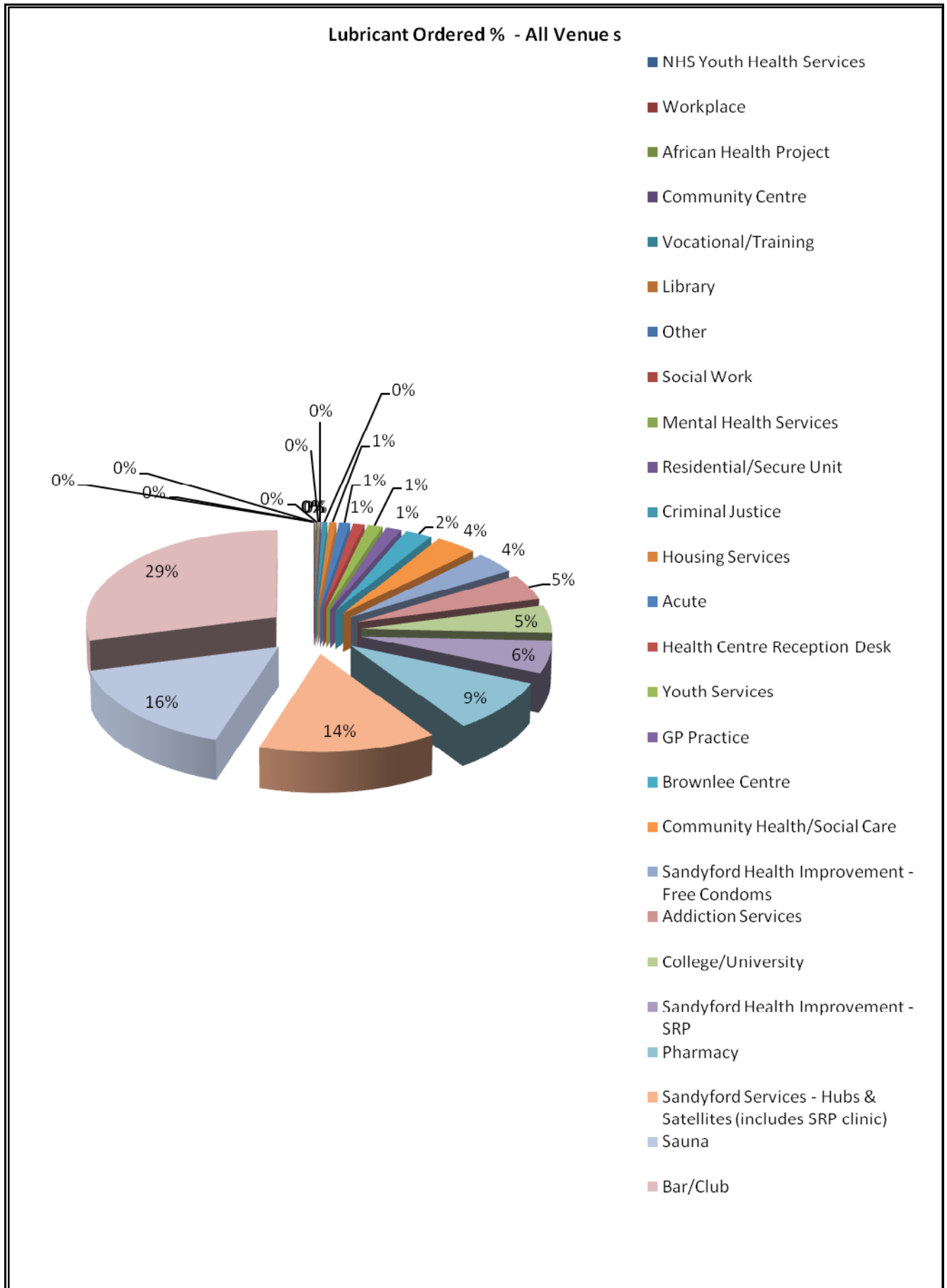


Chart 27 - % Breakdown of Total Number of Lubricant Ordered 2015



## 19. FREE CONDOMS SERVICE TRENDS 2012 – 2015

Comparisons for venues are not exact from year to year as there are venues added and made inactive on an ongoing basis.

### 19.1 Condoms and Lubricant

- There is a reduction in condoms ordered from 2012 – 2015
- Overall there is an increase in the orders for lubricant from 2014 and an increase in the ratio of condoms: lubricant. **Condoms 1,350,150: Lubricant 349,940**
- There was a decrease in condoms and an increase in lubricant from 2014 – 2015.
- There was a higher ratio of condoms: lubricant in 2015 from 2014

Chart 28 - Total Free Condoms Volume Trend 2012 – 2015

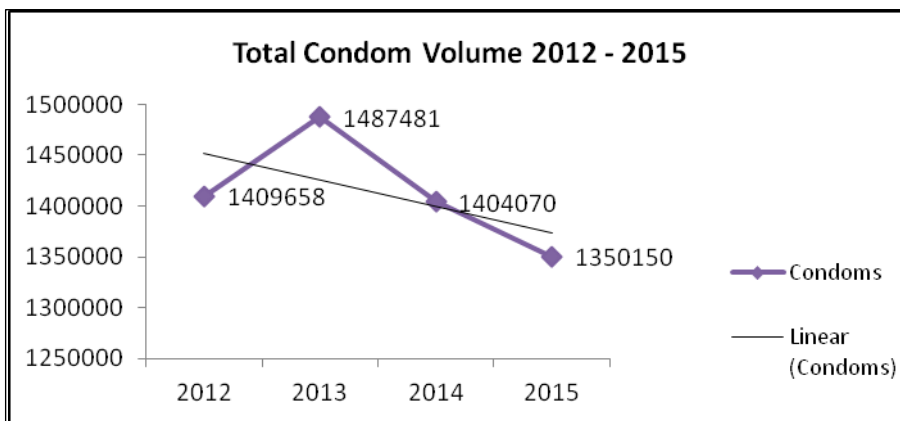
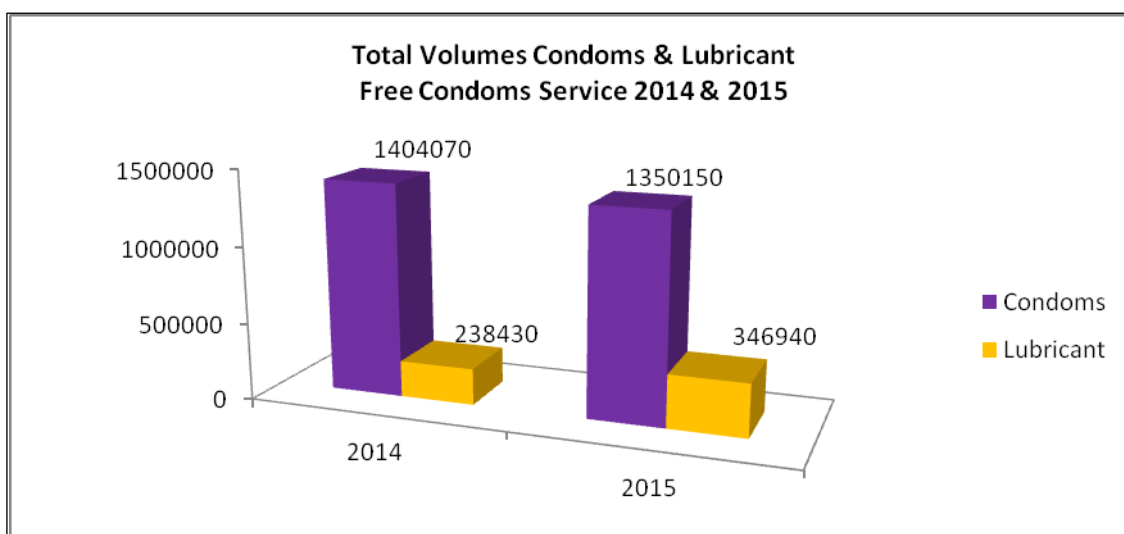


Chart 29 - Total Volume Condoms and Lubricant 2014 & 2015



## 19.2 Possible Impacts on Trends

- In 2013 the Scottish Hydro Arena was completed. This had been a very successful partnership with the Occupational Health Department of Lend Lease, and they regularly placed high volume orders (n=31,800 condoms in 2013). This may be an impact on the number of condoms ordered from 2013 - 2014.
- 2014 condom volume included 83808 condoms ordered for the commonwealth games. Venues were also encouraged to be prepared for the games and advised to increase orders.
- It is possible that what may appear to be trends could indicate a need for improvement in quarterly performance monitoring e.g. improvement in ordering in pharmacies in targeted areas. If this is the case planned improvements in performance monitoring will reflect any change during 2016.
- Some venues may have been overstocked in 2013 (see astronomical point for 2013). Condoms have a long shelf life.

## 19.3 Summary – Discussion Points with Localities & Partners

- There has been a reduction in condoms ordered from for the whole service 2014 – 2015 from **1,404,070** to **1,350,150**. It is not clear if this is a trend in the decrease of use of condoms, or a requirement to support increase of ordering to venues.
- There has been a reduction in condoms ordered by Sandyford Hubs and Satellites from **421,293** to **326,874**. This may reflect a decrease in condom use, people accessing condoms in other venues, and/or be relevant to service changes.
- There has been a reduction in condoms ordered from Brownlee Centre 2014 – 2015 from **38,688** to **21,000**. This should be discussed with partners further to ascertain if it reflects that patients becoming stable on medication and therefore reduced attendances at the Brownlee. It may also be that patients obtain free condoms in venues elsewhere.
- There has been a reduction in condoms ordered from the African Health Project 2014 – 2015 from **43,212** to **28,368**. This may be due to stock being used from the previous year, and take into account that development work/interventions are nuanced and develop over longer timescales in conjunction with other work undertaken by the project. For example, the report from the AHP reflected that 1440 female condoms were distributed as a result of the work undertaken, although none were ordered during 2015.
- There has been an increase in the orders for lubricant during 2015, and an increased ratio of condoms: lubricant.
- Downward trends may change with increased recruitment to gaps in Intermediate Zones and targeted recruitment planned for 2016.
- It is important to consider the overall figures for the service against the provision to SRP/MSM distribution. There was no significant reduction to total units ordered. The streamlined product range and change of ordering model had no effect in the provision of condoms and lubricant to MSM, with financial savings (reduction on spend) from previous years.

## Appendix 3.

### AFRICAN HEALTH PROJECT (WAVERLY CARE) & FREE CONDOMS

#### Mulugeta Asgedom – Working with Men

Waverley care is a charity that provides care and support to people who live with HIV and hepatitis C throughout Scotland. However, the main focus is on prevention and educating the general public about HIV and HIV related stigma. Proper use of condoms/female condoms is the best way to protect people from sexually transmitted infections such as HIV. The African Health Project (AHP) outreach work has been promoting the Free Condoms service among the African communities through events and workshops. The African Health project's outreach work has been promoting the Free Condoms service among the African communities through organising events and workshops. This report outlines the work that has been carried over the last twelve months.

AHP outreach staff and outreach volunteers are responsible for packing and distributing condoms/female condoms for venues. Currently we are working with 8 active and one non active condom venues. These include barbershops, salon, community centre and an African Arts Centre.

The condoms/female condoms are supplied to these venues based on demand /need on a weekly or monthly basis. Outreach staff and volunteers visit the venues to monitor and see if there is a need to top up the condom baskets. Despite the effort to encourage venue owners to be more engaged in promoting the Free Condoms service, they rarely call to remind us about top up. Therefore we have to either visit the venue or call the owner. Efforts continue to ensure effective engagement and partnership between the venue owners and the African Health Project.

The African Health Project continued to promote the Free Condom service with target community group's especially African men. In 2015 the Free Condom promotion was done with a local football team (Glasgow Pirates). After securing funding from NHS Sexual Health Improvement team the African Health Project bought football t-shirts for members of the Glasgow Pirates with Waverley care, Free Condoms and NHS logo on them. The event was attended by the football team, families and friends, AHP staff and a representative from the Sexual Health Improvement Team. Finally talks on the importance of condoms and HIV prevention were given by different speakers.

Another condom promotion event was held at the African Caribbean centre on 22/08/2015. This event was attended by around 40 service users and mostly from the Muslim background.

#### Margaret Lance – Working with Women

During this period of working with women, various interventions strategies were applied to raise HIV awareness with women between 18-65 within Greater Glasgow and Clyde. Activities included women's Health & Wellbeing workshops, sexual health chats with Hair salons, partnership work to show case our services as well as have a better understanding of services delivered by other organisations to maximise referral pathways. We also raise HIV awareness by offering trainings and presentations to partner organisations. Although we have not distributed condoms in the church setting, we have successfully engaged church leaders and their congregation in with meaningful talks, discussions and workshops. Stop talk is a tool which is very useful in recruiting for our trainings workshops and events.

Our work with women and operators of hair salons has seen great improvement in terms of owners getting to understand the importance and benefits of raising HIV awareness for their clients. There has been improved knowledge in seeing an HIV positive client as a person not someone with a condition. We have gradually work with our 3 champion hair salons and have equipped them with tools to gain knowledge on how to protect themselves and their clients in a non stigmatising way. Our work with hair salons has helped to demystify the female condom by allowing clients to touch and feel the product, see product demonstrations, discuss condom negotiation techniques, and an opportunity to ask personal questions.

Sometimes it is hard to engage in a chat as staff can be very busy. As such we either have to wait or come back at a more convenient time. It usually takes time and patience to build trust which we have gradually done with the salons we work with. Visits to salons have shifted from every fortnight to monthly basis.

We believe the free condom scheme has helped in empowering women to rebuild their confidence in negotiating safer sex. What we have learnt in our work is patience, perseverance and to be non-judgmental while confidentiality remains paramount.
